

Standardized Measures around Vaping

PLEASE NOTE: As ‘vaping’ is a delivery device we have focused on the use of **nicotine** as the substance for the measures found below.

If these survey questions are to be combined with other CORE measures and substances, specifically **marijuana or THC**, it would not be necessary to ask the questions with an * as they will be redundant. In this case it is important that any wording around marijuana or THC indicate the various methods of delivery that are now commonly available including -inhaling it, using a vaping device, smoking it, or eating it/edibles.

[^] Age of First Use is no longer a required 4-Core Measure as research has found that recall of age of first use often shifts based on the age of the respondent.
